Dear Mr. Levine:

We represent Bryan Jay Yolles in connection with his Pension Plan. On behalf of Mr. Yolles, we request that you immediately provide him with a copy of the W. B. Doner & Company Equity Pension Plan Summary Plan Description and, if applicable, Statement of Participant's Total Accrued Benefit for any retirement plan that Mr. Yolles participated in while he was employed at Doner. Mr. Yolles and his financial advisor have contacted you and your staff for this information 10 - 15 times – both orally and in writing – since October 2, 2007. As you are aware, under ERISA and the Department of Labor Regulations thereunder, you are required as Plan Administrator to furnish these documents within 30 days of the original request. Accordingly, Doner has been in gross violation of ERISA since approximately November 2, 2007. Additionally, we have been informed by Mr. Yolles that timely information, annual statements, and repeated requests for information about the plan throughout his entire employment at Doner were not provided, as also required by ERISA.

Without this information, Mr. Yolles has been unable to make financial planning, investment or estate decisions to his harm and his family's detriment.

Given the seriousness of this matter, please provide Mr. Yolles with the requested information by Monday, March 17, 2008. If Mr. Yolles has not received the requested information, we will be constrained to aggressively pursue all necessary legal action and remedies, including attorney's fees and associated costs, and reporting these violations to the U.S. Department of Labor and Michigan Secretary of State.
